## DID YOU KNOW THAT...

• "At the start of the pandemic in 2020 congress passed a relief bill that blocked states from ending Medicaid benefits for people who were no longer eligible. Then in December of 2022, Congress passed an omnibus spending bill that changed Medicaid enrollment rules. It says states can begin 'unenrolling' people from Medicaid coverage starting April 1, 2023. It is referred to as "Medicaid unwinding."

Idaho Department of Health & Welfare started sending letters to patients in February 2023.

## **LESSONS LEARNED**

- ☐ Start working on a communication plan early i.e., Mailing postcards, brochures, landing webpage etc.
- ☐ Make it clear to the patients/clients they can re-apply for Medicaid.
- □ Collaborate with insurance agents from the marketplaces.
- □ Open every piece of mail from DHW, and if you cannot read it, bring it to our clinics.

# SAMPLE MAILING

The Idaho Department of Health and Welfare is contacting every Idahoan on Medicaid to determine if they are still eligible for coverage.

You may be asked to complete an application and provide income documentation. If you do not complete the application, you risk losing coverage.

#### What do I need to do so I don't lose coverage?

- Update your contact information with the Idaho Department of Health and Welfare. Visit IdaLink.idaho.gov, call (877) 456-1233 or email MyBenefits@dhw.idaho.gov
- 2. Check your mail for important letters sent from the Idaho Department of Health and We
- 3. Complete your renewal right away so you have no loss in health care coverage.

#### **Medicaid Protection Ending Soon**

#### What is changing?

Medicaid Protection is ending soon, scan to learn how it may impact your Medicaid coverage.

#### What do I need to look out for?

If DHW needs your participation to complete the re-evaluation, you will be sent a notice in the mail letting you know that you must contact IDHW as they will need additional information.

You may opt to call DHW (877-456-1233) or go to idalink.idaho.gov to update your information.

#### Loss of Medicaid




### **BARRIERS**
